

OFFICE ORDER

The following MPHWS (Male) are hereby provisionally promoted on temporary basis as MPHS (Male) in the pay scale of Rs. 9300-34800 + 3200 GP from the date of the joining to the said post, the promotion is further subject to the following conditions:-

1. That in the event of final decision in the disciplinary proceedings which are pending against their seniors, juniors shall have no right on the post of MPHS (male) if their seniors are found fit for promotion after the decision of disciplinary proceedings.
2. They will also not claim seniority above their seniors on the basis of their present promotion and they will be reverted to the post of MPHWS (Male) without giving any notice if any senior to them is/are found fit for promotion to the MPHS (M) later on in the event of decision in the seniority position made by department/court.
3. These promotions have been made strictly in accordance with the provisions in the service rules called as the Haryana Health Department Multipurpose Health Supervisors and Multipurpose Health Workers Group 'C' Service Rules 1984.
4. All the concerned MPHWS (M) who are promoted as MPHS (M) are required to submit their joining report at their posting stations within 21 days.
